

IOWA PAINT HORSE 3 YEAR OLD BREEDERS CLASSIC

Held in conjunction with IPHC Fall Futurity & Show

\$150.00 if paid on or before August 1st

\$300.00 if paid August 2nd through day of show

Postmark will determine strict cutoff date on all payments

I. GENERAL

- A. It is the responsibility of all Breeders Classic participants to know and abide by the all the rules as published.
- B. The Iowa Paint Breeders Classic is to be held in conjunction with the Iowa Paint Breeders Futurity show.
- C. Exhibitors will show to four APHA judges for the Breeders Classic event.
- D. Classes offered will include:
 - 1. 3 Year Old Hunter Under Saddle
 - 2. 3 Year Old Western Pleasure
- E. Eligible horses may show in both classes, entry fee per class is required.
- F. Exhibitors **must be checked in** at the futurity office **at least one hour prior** to the first 3 Year Old Breeders Classic class. **All fees must be paid by this time.**
- G. **Original APHA registration papers must be presented upon check in at futurity office and again when entering the show arena.**
- H. Entries must be shown by the same exhibitor in all goes entered. An entry is not required to show in all goes.
- I. Current APHA rules for Hunter Under Saddle and Western Pleasure will apply.
- J. Transferred horses must be reported by sending a copy of the transfer papers to the futurity secretary.
- K. No substitutions can be made for any entries.
- L. IPHC membership is required of all owners and exhibitors before entry is shown. IPHC membership must be on a separate check from entry payment.
- M. Make checks payable to Iowa Paint Horse Club or IPHC.
- N. Non-sufficient funds checks will automatically be re-deposited. Any check returned not paid by the bank two times will immediately void the entry or entries.
- O. The Iowa Paint Horse Club Treasurer will maintain financial records and an accounting of income, expenses and disbursements.
- P. In the case of withdrawal from competition, disqualification or death, all fees paid are forfeited and shall remain in the Breeders Classic fund to be distributed as purse.
- Q. All entries are subject to APHA rules. Any violation of APHA rules will result in disqualification and forfeiture of any monies earned. Any entry may be subject to drug testing. Owners and/or exhibitors found in violation of APHA rules may automatically be subject to testing at following Breeders Classic or Iowa Paint Breeders Futurity events.
- R. All rules not on this form will follow APHA rules.

II. ELIGIBILITY

- A. ANY offspring from stallions purchased in the 2008 IPBF Stallion Auction, resulting in a 2009 foal, are eligible.
- B. A listing of eligible stallions is available on the Iowa Paint Horse Club website (www.iowapainthorseclub.com).
- C. All eligible horses must be registered with the APHA, either as regular or solid paint bred. Both regular registered and solid paint bred futurity-eligible horses will be shown together in the same class.

III. FEES & ENTRIES

- A. Entry fees paid and/or postmarked on or before August 1 will have an entry fee of \$150.00.
- B. Entry fees paid and/or postmarked on August 2 and until the day of show will have an entry fee of \$300.00.
- C. Mail entry forms and fees to IPBF Secretary: Carrie Gulling, 8370 NE 27th Ave., Altoona, IA 50009.

- D. Exhibitors are responsible for seeking out and adhering to stalling and bedding fees and deadlines for the Iowa Paint Breeders Futurity show.
- E. Each entry will be charged an office fee the day of the show. It is the responsibility of the owner and/or exhibitor of each entry to verify entry form for correctness, the exhibitor, sign the form and pay the office fee and any other monies owed for that entry. It is also the responsibility of the owner and exhibitor to verify current IPHC membership.
- F. A social security number of the person receiving any payback must be declared on the entry form and earnings will be reported to the IRS in accordance with current laws.

IV. PURSE

- A. Each class will pay back 100% of its entry fees, minus expenses.
- B. Each class will pay back 1 place for each 2 entries shown, not to exceed payment of 16 places. Ties will not be broken; premiums will be added and split evenly.
- C. “Day Money” of 15% of the purse will be paid to 5 places per judge.
- D. Any and all premiums earned will be mailed to owners as soon as administratively possible, provided all rules and responsibilities have been met.

V. MISCELLANEOUS RULES

- A. If the bloodlines of a horse are protested, the protestor must deposit \$250.00 cash, money order or certified check with the Futurity Secretary within 10 days of the Breeders Classic. Owner of said horse must make the horse in question available for testing according to current APHA procedure. If the testing proves the correct parentage, the protestor forfeits the deposit. If the testing proves incorrect parentage, the protestor will have the deposit refunded and all costs incurred will be billed to the owner of said horse. Horse will be disqualified and any winnings forfeited. Other contestant(s) will move up accordingly. Owner will be suspended from IPHC and results forwarded to APHA for further action.
- B. Those found in violation of Breeders Classic rules could face the following:
 - 1. APHA notification of findings for further investigation.
 - 2. Up to a five-year suspension from the Breeders Classic and/or IPHC for the participant, or any horses transferred from the individual during the suspension period beginning with the date of violation.
- C. The Iowa Paint Breeders Classic Event is under the direction and supervision of the IPBF Committee.
- D. The IPHC Board of Directors reserves the right to interpret, amend and enforce the above rules. Any decision concerning the application or interpretation of these rules by the IPHC Board of Directors shall be final. Any person participating in the Breeders Classic including, but not limited to, owners, exhibitors, handlers and cosignors shall indemnify and hold harmless the Iowa Paint Horse Club, its officers, directors and employees from and against all claims, demands, causes of action and expenses of every kind including attorney fees, arising out of or related in any manner to the acts or omissions of an owner, exhibitor, handler or cosignor, or the actions of any animal under the care, custody or control of the owner, exhibitor, handler or cosignor. Every person and legal entity, by participating in this event, does thereby agree:
 - 1. If unsuccessful in an attempt to overturn Iowa Paint Horse Club decisions, actions, rules or regulations, to reimburse the Iowa Paint Horse Club for its reasonable attorney fees, court costs and other reasonable expenses incurred in defense of such suit.
 - 2. That no action will be commenced, whether in law or equity, against the Iowa Paint Horse Club in any court other than the Iowa District Court for Polk County.
