**IPHC BOARD MINUTES** 

August 1<sup>st</sup>, 2012 Marshalltown, IA

Board Members Present: Michelle Kelber, Lonnie McLain, Kimberly Borcherding, Jeannie Stolee, Carrie Gulling, Kim Kass, Terri Bohnsack, Clint Roth, Earl Vold, and Jerry Cable.

President Michelle Kelber called the meeting to order.

Minutes from the previous meeting were read. Kim Kass moved to approve the minutes. Terri Bohnsack  $2^{nd}$  – MC.

Jeannie Stolee presented the treasurer's report. Carrie Gulling moved to approve the treasurer's report, Kimberly Borcherding 2<sup>nd</sup> - MC.

### Bills to Pay:

Lonnie McLain made motion to reimburse \$70.00 stall refund from the 2011 futurity show that was mistakenly written out of the Breeders checking account to the IPHC club account. Terri Bohnsack  $2^{nd} - MC$ 

### Show Profit/Loss Statements

Jeannie Stolee gave the profit/loss statement from the July Iowa Falls show. The profit for the show was \$4985.61

### Directory

Jeannie Stolee presented a discussion on the 2012 directory. There were issues with the way ads were sold and paid for. Due to the situation, it has come to the Board's attention that the accounting of the ads that were sold may not have been correct. The Board discussed possible options to take regarding the situation. Lonnie McLain made a motion to take a wash on the directory and not attempt to collect on the unpaid ads. Carrie Gulling 2<sup>nd</sup>. More discussion was held and Lonnie made a motion to amend his motion to also include that the IPHC would not pay anything to Linda Raub, who produced the directory, or invoice any advertisers for the unpaid ads. Terri Bohnsack 2<sup>nd</sup> the amendment. The amended motion was voted on, MC, 1 abstained.

For the 2013 directory, checks for advertising will be made out to the IPHC directly. The Board will accept bids for the directory and it will be advertised on the website.

### Memorial Day Photographer

Brian Baldrige has not mailed out the photos he took at Memorial Day. He is also not answering emails or phone messages. Jeannie Stolee will send Brian a certified letter. Kim Kass volunteered to also attempt to contact him.

### Futurity and State Show

The showbill and stall forms are up on the website. The fairgrounds will be open for move-in beginning on Thursday at 2pm. Kimberly Borcherding will update the fees page for the website and send it to Jeannie Stolee for upload to the website.

The meal celebrating Gregg Reisinger will be held on Friday at 6:30pm somewhere in the barn area. Lonnie McLain and Carrie Gulling investigated food providers and presented some options. Turkey Time was \$11 per person and Great Caterers of Iowa is \$7 per person. Carrie made a motion to use Great Caterers of Iowa for the meal and IPHC pay for a cake. Clint Roth 2<sup>nd</sup> – MC. Lonnie will check with the caterers to make sure table service and drinks are included in the price.

Lonnie advised that he was approached by Iowa Quarter Horse Association President Butch Hammer regarding stalling options for Breeders Halter Futurity and Nationwide Halter Championship exhibitors. Butch has been approached by several people looking for stalls on our futurity weekend, as the National Halter Championships and Breeders Halter Futurity begin the following week. Lonnie suggested that we allow anyone for the BHF and NHC to purchase excess stalls during our futurity. Their arena access will be limited to open arena times only. Prices will be set at \$70/\$90, the same as IPHC Futurity prices.

Vendor costs will be set at the same prices as last year. Kimberly Borcherding suggested discounting vendor fees if they donate a prize to the show. The vendor forms will be available online. Michelle Kelber and Kaitlin Westphal will be in charge of vendors.

### **Breeders Classic**

Entries for the new 3 year old Breeders Classic classes are low, with one in the hunter under saddle and two in the western pleasure. Carrie Gulling made a motion to add \$500 to each class purse and extend the deadline for the lower entry fee until August  $15^{th}$ . Earl Vold  $2^{nd}$  – MC.

There was no old business to discuss.

### **New Business**

October show stalls were discussed. Since we are having flat fees at the show, tack and extra stalls for un-entered horses will be set at \$75 each, with 2 bags of shavings included for each.

### Year End Awards

Kim Kass was approached by the parent of a 13 and Under youth. There is concern that some of the 13 & Unders are not earning any state points and will therefore be ineligible for year-end awards, despite the year end awards being split into separate divisions. Discussion was held but no action will be taken at this time.

The next meeting will be held on October 12<sup>th</sup> in Kirkwood Equestrian Center at 7pm.

Lonnie McLain made a motion to adjourn the meeting, Kim Kass 2<sup>nd</sup> – MC. Meeting adjourned.

### Memorial Day 2012

Jeannie Stolee presented an idea for a revised schedule to our Memorial Day Classic show. Jeannie suggested instead of having a full slate of classes for each of the three days, we hold the performance classes with four judges each day on Saturday and Monday, and Sunday hold the halter and showmanship only, with eight judges. This change would impact our Paint-O-Rama at the State Show, as we are only allowed two PORs per year. Jeannie's plan suggests offering a youth-amateur POR at the State Show. Benefits would include open exhibitors being able to show to eight judges, rather than the current six at Memorial Day. Also, cutting two judges from Memorial Day would lower costs and would allow performance horses to have a break day on Sunday, rather than showing all their classes, all three days. We will consider the proposal and decide on our plans for next year's shows at a later date.

Trail Ride Jerry Cable will look into possible dates for this year's trail ride.

Old Business There was no old business discussed.

Taylor Kokemiller presented a written youth report. The youth continue to do well with their fundraisers, raising a total of \$1240.00 at the Memorial Day show.

### By Laws

One possible idea was having one representative from each district and four additional at-large representatives. More discussion will be held at a later date.
